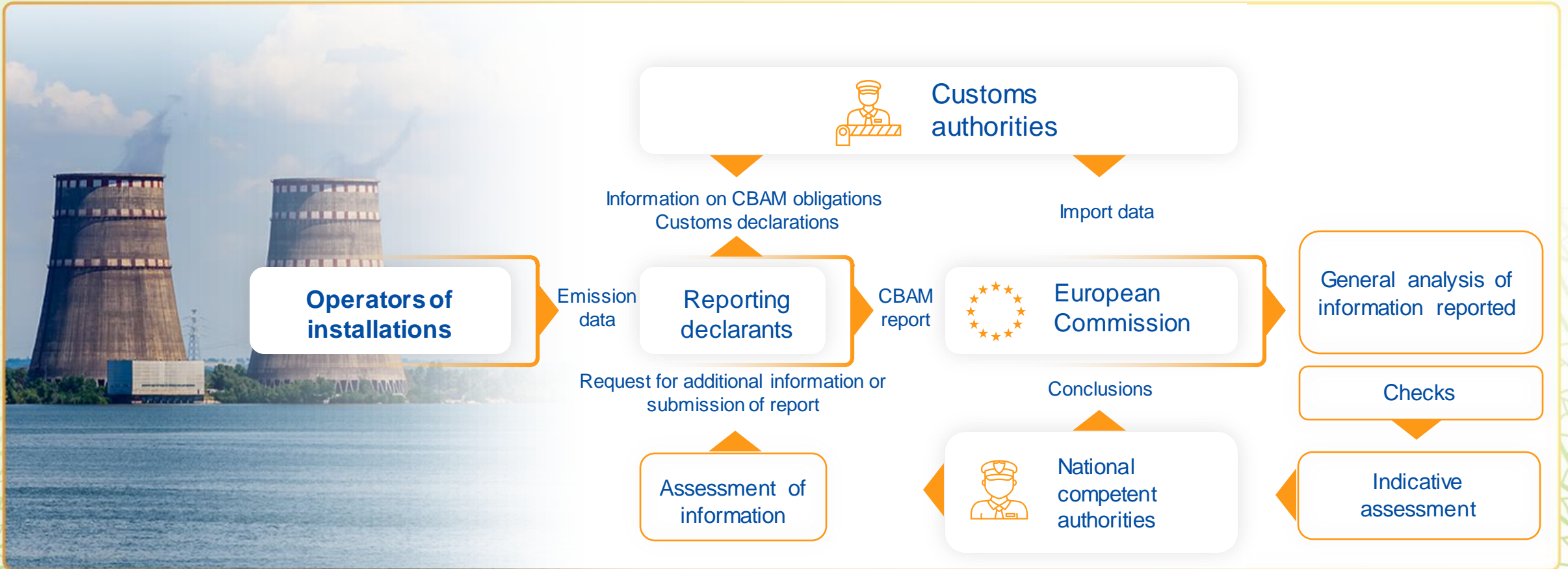

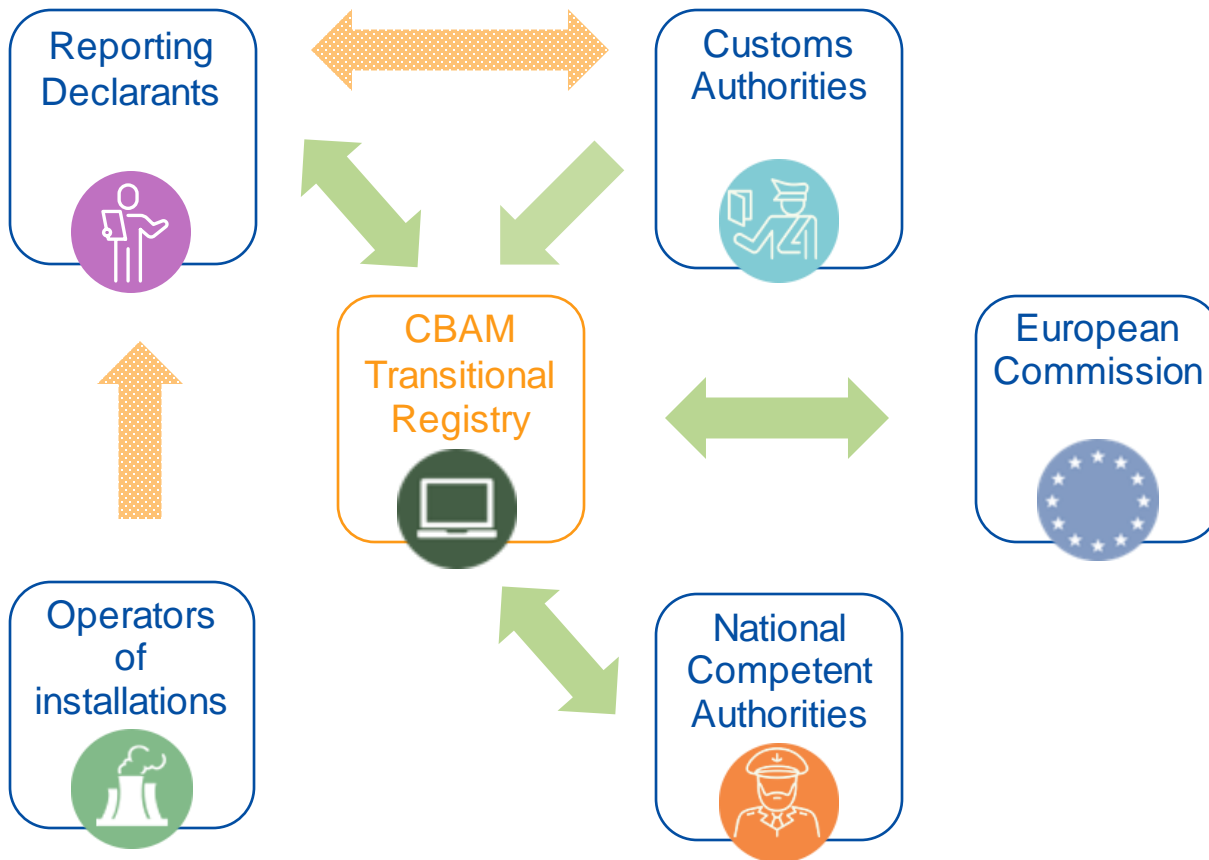

Who are the actors in CBAM? 1/2

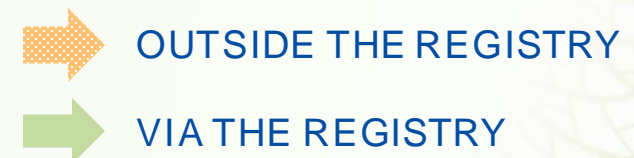


Who are the actors in CBAM? 2/2



Key highlights

- Single platform to create synergies
- Tool to perform CBAM-related tasks
- Secured platform to ensure confidentiality of information



What is the reporting obligation in the transitional period?

October 2023 – December 2025

CBAM report containing the following:

- Total quantity of goods imported during the preceding quarter
- Total embedded direct and indirect emissions
- The carbon price due in the country of origin for the embedded emissions

Report to be submitted quarterly

**No verification of emissions by
EU-accredited verifier**



No CBAM certificates

What are the reporting timelines?

REPORTING PERIOD	SUBMISSION DUE BY	MODIFICATION POSSIBLE UNTIL *
2023: October – December	2024: January 31	2024: July 31
2024: January – March	2024: April 30	2024: July 31

2024: July – September	2024: October 31	2024: November 30
2024: October – December	2025: January 31	2025: February 28
2025: January – March	2025: April 30	2025: May 31

2025: July – September	2025: October 31	2025: November 30
2025: October – December	2026: January 31	2026: February 28

**After the modification deadline, reporting declarants may request reopening of the file before the national competent authority for eventual corrections.*

How to request access to the CBAM Transitional Registry

Request access (New/Update/Removal)

User Access Management is a Request for Service that can be one of the following categories:

Request access rights to the CBAM Transitional Registry

Removal or amendment of access rights to the CBAM Transitional Registry

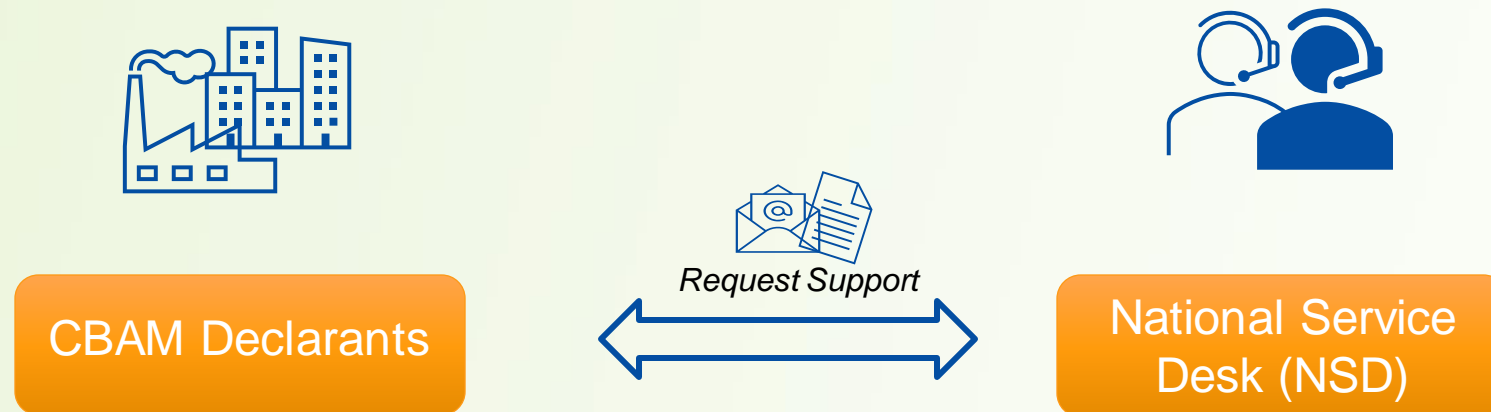
User Registration Instructions

CBAM Declarant should do the following:

- **CBAM Declarant requests access to the CBAM Declarant Portal through the National Service Desk**
- **Contact Points for the National Competent Authorities are provided in the [Public Europa site](#)**

Support provided by the National Service Desk

In the support interaction with CBAM Declarants, National Competent Authority is represented by its National Service Desk (NSD)



General Steps for Support



For User Access Management issues, contact your National Service Desk.



For any issue related to the submission of the quarterly report, please follow the steps below:

1. Address to the CBAM portal for the e-Learning material
2. Consult the user guides at the CBAM portal
3. Refer to any other relevant online material
4. Create a service request to the National Service Desk

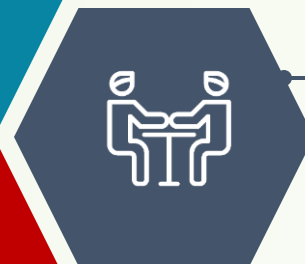

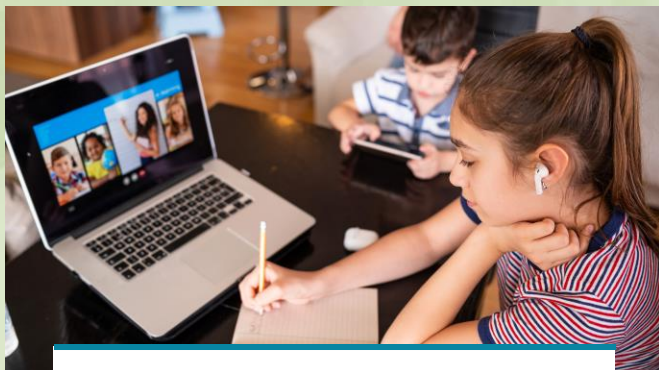


Types of Support provided by the National Service Desks

CBAM Declarants may face issues that are divided into the following 3 categories:

TYPES OF SUPPORT	DESCRIPTION
User Access Management Support	User access issues blocking the CBAM declarant from Logging in to the CBAM Transitional Registry. i.e. Request from CBAM Declarant on error messages received when attempting to authenticate.
Technical Support	Technical related issues or constraints that create a blocking point for the CBAM Declarant. i.e. Request when a CBAM Declarant chooses an option from a drop-down list when completing a declaration.
Business Support	Business related requests or constraints that create a blocking point for the CBAM Declarant.
