# **Proof of Union Status System** for Economic operators

The Proof of Union Status (PoUS) system is the IT system for managing, storing, and consulting proofs of the customs status of Union goods.

The PoUS system allows customs authorities to store and exchange proof of Union status document data across the EU, and it allows economic operators to interact with customs officers of any Member State in a consistent way. This electronic infrastructure will refine the processes related to the proofs of Union status of goods.

## Scope

Thanks to this eLearning course, you will become familiar with the PoUS system and the legal framework in which it fits, learn how it works and understand when and how to use it.

Moreover, you will be shown two case stories to get an overall view of the business process related to proof of Union status.
