# Import Control System 2 (ICS2)

Import Control System 2 (ICS2) is an IT system designed to collect data on all goods entering the EU before their arrival. The goal of the system is to better protect Europe's single market and its citizens through the implementation of new customs safety and security measures. These measures aim to improve threat detection, streamline trade, and enhance information exchange between economic operators and customs authorities.
